 Inform members of your Business office about the many financial advantages sustainability practices offer. Grant opportunities also exist through Sustainable New Jersey Schools.



# Medford's Implementation for Cost Containment


- Nearly 70% of our schools electrical needs are generated by on site renewable energy. (solar)


