New! Roots for Rivers Reforestation Grant and Technical Assistance Program

The Nature Conservancy (TNC) is partnering with Sustainable Jersey and the Watershed Institute to offer another round of Roots for Rivers Reforestation Grant and Technical Assistance Program. The program will support municipal, school district, and local non-profit and conservation organization efforts to undertake their own floodplain reforestation initiatives.

Program participants will receive technical assistance to design restoration projects and funding to cover the material costs of eligible expenses that only include native tree/shrubs, tree protection tubes, stakes and up to two delivery fees. All other expenses will be the financial responsibility of the applicant. Projects costing between \$1,000 and \$20,000 are eligible. Click [here](#) for more information. Grant Cycle for Energy Projects



The Gardinier Environmental Fund is contributing \$150,000 to support a Sustainable Jersey Grants Program cycle for [municipalities](#) and [schools](#). Collaboration on projects between municipalities and schools is encouraged. For this cycle, the Gardinier Environmental Fund will fund energy projects focused on energy conservation, energy efficiency, and renewable energy. The cycle will award **two \$30,000 grants and nine \$10,000 grants**. 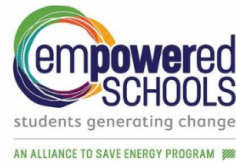

There's Still Time to Become a PowerSave School!



Sustainable Jersey has partnered with South Jersey Gas and the Alliance to Save Energy to bring the PowerSave Schools program to schools within the South Jersey Gas territories. Dodge Foundation in partnership with the Community Foundation of New Jersey has established Field Trip New Jersey, a fund that makes field trips possible for more students across an even wider range of disciplines and interest areas. Integrated Pest Management Training

Integrated Pest Management training sessions are offered for school IPM Coordinators and other school personnel with administrative responsibilities in accordance with the new IPM laws. IPM Coordinators receive certification of attendance to fulfill the mandatory training requirement as stated in the NJDEP Pesticide Control Program regulations. These sessions help IPM Coordinators implement the new IPM law with regards to such things as: non-pesticide pest management, parental notification, the 72 hour notification rule, low-impact pest management; record keeping, and dealing with pest emergencies. 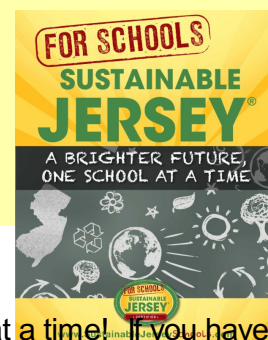
