Sustainable Jersey has partnered with New Jersey Natural Gas (NJNG) and the Alliance to Save Energy (ASE) to bring the PowerSave Schools program to thirty five schools within NJNG's service area. **Thirteen additional Sustainable Jersey-registered schools, along with twenty two returning, will be admitted for the 2019-2020 school year.** PowerSave Schools directly engages students with Science, Technology, Engineering and Mathematics (STEM) principles to promote energy literacy throughout lesson plans, activities and competitions.



It Pay\$ to Plug In: New Jersey's Electric Vehicle Charging Grants Program

It Pay\$ to Plug In provides grants to offset the cost of purchasing and installing electric vehicle charging stations. The program is designed to expand New Jersey's growing network of electric vehicle infrastructure, allowing residents, businesses, and government agencies to purchase and drive electric vehicles. EVs dramatically reduce vehicle emissions and improve air quality for everyone.

It Pay\$ to Plug In has expanded its eligibility criteria to include workplaces, public places, and multi-unit dwellings (apartments, condominiums, and townhouses). The program is open to businesses, governments, non-profit organizations, and educational institutions. Private residential dwellings other than multi-unit dwellings are not eligible for grants.

Upon completion of work in accordance with the eligibility criteria, DEP will reimburse each applicant for a percentage of eligible costs up to a maximum of:

- \$750 per Level 1 charging station
- \$5,000 per single-port Level 2 charging station
- \$6,000 per dual-port Level 2 charging station
