

# FREE Technical Assistance for Energy Initiatives

Sustainable Jersey is pleased to offer New Jersey municipalities and school districts a unique opportunity to participate in the <a href="Environmental Defense Fund">Environmental Defense Fund</a>'s (EDF) <a href="Climate Corps program">Climate Corps program</a>. The program will provide an EDF Climate Corps Fellow, typically a Master's student, (MBA or similar background), with in-depth training in energy project assessment and development, to work onsite at the municipality or school district during the summer of 2020 for approximately 9-10 weeks (part-time, as each EDF Fellow works with more than one local government unit). EDF Fellows provide expertise to help municipalities and school districts take advantage of utility and <a href="New Jersey's Clean Energy Program">New Jersey's Clean Energy Program (NJCEP)</a> incentives for energy efficiency audits and facility and/or equipment upgrades that can save significant amounts of energy and money.

EDF Fellows will be made available as follows:

- Thanks to support from New Jersey Natural Gas (NJNG), three Fellows will be available to
  work with Sustainable Jersey municipalities and school districts located within their utility

#### **Integrated Pest Management Training**

Integrated Pest Management (IPM) training sessions are offered for school IPM Coordinators and other school personnel with administrative responsibilities in accordance with the new IPM laws. IPM Coordinators receive certification of attendance to fulfill the mandatory training requirement as stated in the New Jersey Department of Environmental Protection Pesticide Control Program regulations. These sessions help IPM Coordinators implement the new IPM law with regards to such things as: non-pesticide pest management, parental notification, the 72 hour notification rule, low-impact pest management; record keeping, and dealing with pest emergencies. Participants will receive 4 Continuing Education Units (CEUs). This training support the <a href="Integrated Pest Management">Integrated Pest Management</a> action toward Sustainable Jersey for Schools certification. # NJBPU Announces New Incentives to Expand Local Government Electric Vehicle Fleets

To jump-start the electrification of local government vehicle fleets, the New Jersey Board of Public Utilities (NJBPU) has created the "Clean Fleet Electric Vehicle Incentive" program, which offers local governments \$4,000 per battery electric vehicle and \$1,500 for one dual-port Level 2 EV charging station. The application window opened on December 1, 2019, and the program will award grants on a rolling basis until April 15, 2020 or until the funding is fully committed. Eligible applicants are local government authorities, which includes school districts, counties, municipalities, and local utility authorities in New Jersey.

To make it easier for local governments to add electric vehicles to their fleets, EVs were recently

adding to the State Purchasing Contract. Please review Sustainable Jersey's <u>Alternative Fuel Vehicle Procurement Guide</u> for further details. Sustainable Jersey for Schools points can be earned for the new Sustainable Fleets action in the Green Purchasing category.

# It Pay\$ to Plug In: New Jersey's Electric Vehicle Charging Grants Program

It Pay\$ to Plug In provides grants to offset the cost of purchasing and installing electric vehicle charging stations. The program is designed to expand New Jersey's growing network of electric vehicle infrastructure, allowing residents, businesses, and government agencies to purchase and drive electric vehicles. EVs dramatically reduce vehicle emissions and improve air quality for everyone.

It Pay\$ to Plug In has expanded its eligibility criteria to include workplaces, public places, and multiunit dwellings (apartments, condominiums, and townhouses). The program is open to businesses, governments, non-profit organizations, and educations institutions. Private residential dwellings other than multi-unit dwellings are not eligible for grants.

Upon completion of work in accordance with the eligibility criteria, DEP will reimburse each applicant for a percentage of eligible costs up to a maximum of:

- \$750 per Level 1 charging station
- \$5,000 per single-port Level 2 charging station
- \$6,000 per dual-port Level 2 charging station
