Tips on Completing Your Certification Application

The final deadline for 2020 Sustainable Jersey for Schools certification is June 22. In this webinar we will show you how to respond to feedback from previous submission rounds. We will also discuss how to complete some of your actions during this time of social distancing and school closures.

Get free support and resources, as well as a stipend, to educate students about energy use and save money on your school's energy costs.

Sustainable Jersey is partnering with New Jersey Natural Gas (NJNG), South Jersey Gas (SJG), and the Alliance to Save Energy (the Alliance) to bring the PowerSave Schools program to 37 schools in <u>NJNG's service territory</u> and 30 schools in <u>SJG's service territory</u>.

Created by the Alliance, PowerSave Schools engages PK-12 students in saving energy and money in their schools – and now, in their homes, too. In response to the COVID-19 school closures, the Alliance developed "EmPowered at Home", a new component of PowerSave Schools designed to be administered remotely. EmPowered at Home ensures the program's success in remote, in-school, or hybrid learning models. With NJNG and SJG funding, the Alliance provides the training, guidance, tools, and resources for a successful program.

The importance of a complete count in the <u>2020 Census</u> cannot be overstated – census counts determine nearly \$23 billion in federal funding for New Jersey, including support for school programs

and services such as special education, free and reduced lunch, class size reduction, classroom technology, after-school programs, Head Start and more.

Even during this time of social distancing and remote learning, information encouraging completion of the Census online, over the phone or by mail can still be sent to families through school communication channels.

Social Emotional Resilience: Supporting School Communities Through Crises

NJBPU Announces New Incentives to Expand Local Government Electric Vehicle Fleets

To jump-start the electrification of local government vehicle fleets, the New Jersey Board of Public Utilities (NJBPU) has created the "Clean Fleet Electric Vehicle Incentive" program, which offers local governments \$4,000 per battery electric vehicle and \$1,500 for one dual-port Level 2 EV charging station. The application window opened on December 1, 2019, and the program will award grants on a rolling basis until the funding is fully committed. Eligible applicants are local government authorities, which includes school districts, counties, municipalities, and local utility authorities in New Jersey.

To make it easier for local governments to add electric vehicles to their fleets, EVs were recently adding to the State Purchasing Contract. Please review Sustainable Jersey's <u>Alternative Fuel Vehicle</u> <u>Procurement Guide</u> for further details. Sustainable Jersey for Schools points can be earned for the new <u>Sustainable Fleets</u> action in the Green Purchasing category.
