83 New Jersey Schools Achieve Sustainability Certifications

Sustainable Jersey for Schools announced today the 83 schools that achieved the Sustainable Jersey for Schools certification. The 83 schools come from 24 different school districts across 13 New Jersey counties. In two years, 118 schools have achieved Sustainable Jersey for Schools certification. 30 Schools from 18 NJ Counties Receive Grants to Fund Health and Wellness Actions

Sustainable Jersey for Schools announces the thirty New Jersey schools that were selected to receive a Sustainable Jersey for Schools Small Grant of up to \$4,000 funded by the New Jersey Department of Health. These grants will support school health and wellness initiatives

"Sustainable schools are healthy schools, and schools that promote health and well-being will see benefits," said Donna Drewes, who co-directs Sustainable Jersey with Randall Solomon. "These grants funded by the New Jersey Department of Health will support schools as they tackle important health and wellness actions."

The New Jersey Department of Health is funding the grants through its Maternal and Child Health Services Title V Block Grant. NJDOH has three regional partners that will provide assistance and support to help schools successfully carry out the funded project. AtlantiCare (south), EmPoWER Somerset (central) and The Center for Prevention and Counseling (north).

Proposals were reviewed by an independent Blue Ribbon Selection Committee. The Sustainable Jersey for Schools grants are intended to help school districts and schools make progress toward a sustainable future in general, and specifically toward Sustainable Jersey for Schools certification. Since 2015, \$706,000 in grants has been provided to New Jersey districts and schools.

\$180,000 in Grants Now Available to Fund NJ School Sustainability Projects

Sustainable Jersey for Schools announces the availability of \$180,000 in new grants funded by the New Jersey Education Association (NJEA). This 2016 Sustainable Jersey for Schools Small Grants Program cycle funded by NJEA will award: **ten \$10,000** grants to school districts or schools and **forty \$2,000** grants to support school green teams. Applicants must be registered in the Sustainable Jersey for Schools program which is free and voluntary. The funded projects will serve as practical and innovative models for the rest of the State and make measurable contributions toward the long-term goal of a sustainable New Jersey.

Wanted: Innovative NJ Sustainable Energy Projects

The Gardinier Environmental Fund is contributing \$150,000 to support a Sustainable Jersey Small Grants Program cycle for both municipalities and schools. This cycle will award two (2) \$35,000 grants and eight (8) \$10,000 grants.

For this cycle, the Gardinier Environmental Fund will fund energy projects focused on conservation, efficiency, and renewable energy. One **example** of an acceptable energy project is a propane bus fleet, which can save between 40% - 50% on fuel costs. 
