



Bicycle and/or Pedestrian Audit (5 pts)

What to submit to get points

- 1. Submit a copy of the Bicycle and/or Pedestrian Audit, which must include:
 - Survey of existing infrastructure conditions
 - Description of opportunities and constraints (gaps and barriers)
- 2. The Bike and/or Pedestrian Audit must be no more than 5 years old at the time of submission.





Bicycle and/or Pedestrian Plan (10 pts)

Why

 Build healthy communities that support active living and reduce reliance on automobile.

Will involve

- Planning Board
- Project Steering Committee
- Internal staff, municipal committee members and/or consultants









Bicycle and Pedestrian Plan (10 pts)

What to submit to get points

- Vision, goals, objectives
- Existing conditions analysis
- Recommendations on policy changes, programs and improvements
- Implementation plan/strategy
- Adopt as part of Municipal Master Plan by Planning Board Resolution







Smart Workplaces – Gold and Platinum

Why

 Improve air quality as well as reduce vehicle miles traveled and greenhouse gas emissions

What to Do

- Create alternative commute programs and utilize transportation demand management strategies for employees
- Work with your local Transportation Management Association toward gold or platinum recognition





Smart Workplaces – Gold and Platinum





- Points for NJSW gold (5 pts) and platinum (10 pts) levels
- Gold = 5 bronze- +
 5 silver-level activities
- Platinum = gold + sitespecific alternative commute program

Sample Eligible Activities

- Host commuter information events
 for your employees
- Host a carpool or vanpool formation event
- Offer a flextime or telecommuting program
- MADISTRAVENUI

- Sell transit passes on site
- Provide employees access to basic bike maintenance tools
- Provide employer-subsidized shuttle
- Provide electric vehicles and charging stations for business use



Smart Workplaces – Gold and Platinum

What to submit to get points

- Documentation of Gold or Platinum Level NJSW recognition
- Recognition must have occurred within 18 months of submission

Recycling & Source Reduction Actions

- 13 Existing Waste Management Actions
 - 7 Recycling and 6 Waste Reduction
- Historically the actions have been very logical and specific
- Reason for 5 Adding New Actions
 - Flexibility both in recycling activities and submission requirements
 - Example: Submission requirements include either adopted ordinance, or no ordinance in place but recycling still occurs
- Future Goals
 - Focus on performance metrics based on Municipal Tonnage Grants Program data



Five New Waste Management Actions

- Prescription Drug Safety and Disposal
- Commercial & Institutional Recycling
- Reusable Bag Education Program
- Education & Enforcement
- Non-Mandated Materials Recycling





Prescription Drug Safety and Disposal

Why is it Important?

 Need to address antibiotics, anti-convulsants, mood stabilizers and sex hormones in groundwater

What to Do and How to Do It

- Link to DEA National Take-Back Day, Project Medicine Drop, P2D2,
 RX4Safety, American Medicine Chest Challenge or own program
- Coordinate with law enforcement

Submission Requirements

Establish permanent drop off location or conduct at least 2 drop off events/year

• Point Value: 10 points



Commercial & Institutional Recycling

Why is it Important?

No dedicated tracking of performance in NJ; significant non-compliance,
 need to reach 50% state-wide recycling goal

What to Do and How to Do It

- Ordinance in place OR no ordinance, but recycles options
- Example Activities: Municipality-wide inventory of generators, tracking system for stores/schools, food waste collection/recycling in restaurants, recycling competitions, recycling at sports venues.

Submission Requirements

Ordinance and promotional materials OR promotional materials, implementation plan, tonnage reports

Point Value: 10 points

Reusable Bag Education Program

Why is it Important?

- Hot topic in the New Jersey Legislature and bans and surcharge programs proposed
- 500 billion plastic bags used annually worldwide
- Bags contribute to litter, clog MRF equipment, "Green Fence" Initiative in China at same time single stream popularized

What to Do and How to Do It

- Ongoing education program with short and long range plans
- Example Activities: Public announcements, business outreach, linkages to schools, "Bag Care" component on hygiene"

Don't Forget Your Reusable Bags!

Submission Requirements

- Program outreach/educational materials, photos,
- Optional: ordinance or resolution of support
- Point Value: 5 Points

Education & Enforcement

Why is it Important?

- Many misconceptions about recycling & source reduction so education is critical
- Recycling enforcement often non-existent

What to Do and How to Do It

- Ordinance in place OR no ordinance, but recycles options
- Develop rewards/penalties and accepted materials recycling flyer
- Example Activities: Focus on difficult sectors businesses, institutions, office complexes, schools, multi-family housing, sports venues.

Submission Requirements

- Ordinance with rewards/penalties, accepted materials recycling flyer,
 promotional materials, plans/vendor contracts, tonnage reports
- Point Value: 5 Points



Non-Mandated Materials Recycling

Why is it Important?

- "Catch-all" action area, and allows for flexible submissions
- Pertains to either source reduction or recycling

What to Do and How to Do It

- Ordinance in place OR no ordinance but recycles must go beyond recycling county mandated materials
- Example Activities: Toy take-back, clothing or textile recovery, recycling and marketing of 3-7 plastics

Submission Requirements

- Ordinance, promotional materials, tonnage reports
- Point Value: 10 Points



New Jersey state law (N.J.S.A. 58:10B-23.d):


"any former or current commercial or industrial site that is currently vacant or underutilized and on which there has been, or there is suspected to have been, a discharge of a contaminant."





Brownfields

- Hazardous to environment & human health
- Unsafe Eyesore
- Block neighborhood (re)development
- Hinder achievement of longterm municipal goals

Brownfields Action Process





Brownfields Action 1 Inventory & Prioritization (10 pts)

- (Required) Inventory information downloaded from DEP
 Dataminer and a written policy for regularly updating the
 Brownfields Inventory that includes who is responsible and
 how often this will occur.
- (Required) Documentation of all public meetings pertaining to development of the prioritization factors, a description of the weighted factors used to determine priority Brownfield sites, and a listing of the priority sites.
- Mapping based on the Block/lot information or the X/Y coordinate information.







Action 2 Brownfields Re-Use Planning (15 pts)

Reuse Data

Upload SiteMart data sheets demonstrating that you have collected additional information for all prioritized Brownfield sites. The SiteMart data sheets must at a minimum include: current site description, current zoning, information on accessibility, site stakeholders, land use of adjacent properties, and redevelopment/rehabilitation area designations if applicable.

- Public meeting notes and conclusions
 - Upload meeting notification documentation and minutes of public meeting(s) held to discuss various reuse options. Meeting minutes should include a synopsis of the methods used to advertise the public meeting, as well as a sign-in sheet from the meeting and any conclusions regarding the recommended targeted reuse options.
- Mayor & Council Resolution endorsing the proposed reuse(s)
 Upload a copy of the certified resolution indicating prioritized Brownfield sites and recommended reuse option(s)
- Brownfields Reuse Element or Redevelopment Plan for municipal Master Plan
 Upload a copy of the certified resolution approving incorporation of a Brownfields Element
 into the community's Master Land Use Plan and a copy of the Brownfields element.
 Alternatively, if the municipality has completed a Redevelopment Plan, which has been
 passed by the Mayor & Council and added to the Master Plan, the Resolution authorizing the
 Plan and the Plan itself may be submitted in lieu of a Master Plan Brownfields Element

Establish a Creative Team

Pre-Requisite for other "Arts and Creative Culture Actions."

- Like a Green Team, but focused on arts and culture
- Small, but diverse and representative
- Authorized to oversee creative asset inventory and development of Creative Placemaking Plan

The creative team is not necessarily your local arts council



Getting points (10)

- Team is authorized to meet
- Team meets and develops mission and structure
- Team defines area of concern (single municipality to region)
- Team undertakes activities (such as public engagement sessions) and reports on them



Why a Creative Placemaking Plan?

- Provides direction and focus
- Indicates priorities
- Identifies values for taking action
- Connects ideas through a verbal/visual composition
- Provides guidance to investors and funders



The Plan should connect arts with...

- Community development: Improving quality of life for more people
- Economic development: *Enhancing* opportunities for prosperity for more people
- Cultural development: Building a healthier climate for individual and cultural expression
- Sense of place
- Existing and accessible assets



The Plan must answer these types of questions:

- Who...
 - ...benefits ...is involved in the plan ...should do what ...etc.
- What...
 - ...is recommended ...are the issues being addressed ...are the priorities for action ...etc.
- Why...
 - ...is this plan being done ...were these the issues selected ...etc.
- How...
 - ...will the strategies address the issues ...etc.



What should the Plan say or look like?

- It's up to your Creative Team
- It's a points-earning plan if...
 - ...it can provide a clear sense of focus, direction, strategies and values for decision-making
 - ...it identifies issues clearly and explains why they matter to making a better place
 - ...it shows clear connections between the placemaking issues identified and the arts strategies recommended
 - ...the local Planning Board is willing to incorporate it into the municipality's Master Plan
